Sub: Selection of the Implementing Agency – regarding.

Sir/Madam,

Para 2.11 (b) of the Guidelines on MPLADS relating to Implementing Agency provides as follows:

(b) The selection of the Implementing Agency shall be undertaken in accordance with the state Government rules/guidelines applicable for the purpose. Provided that for certain works in certain Central Government Ministries/Organization (like Railways) where the Implementing Agency has necessarily to be the concerned Central Government Ministry/Organization, the same shall be selected as the Implementing Agency.

2. Though, the Guidelines do not bar District Authorities for selecting Central Government Agencies which have good track record in implementation of large infrastructure projects for Implementation of MPLADS works as well, to widen the scope of selection of Implementing Agency by the District Authority, it has been decided to amend para 2.11(b) of the Guidelines on MPLADS to specify that Central Government Agencies such as CPWD, NBCC etc., may also be considered for selection of Implementing Agencies.


3. Therefore, it has been decided that para 2.11 (b) of the Guidelines on MPLADS may be read as follows:

“(b) The selection of the Implementing Agency shall be undertaken in accordance with the State Government rules/guidelines applicable for the

purpose. While selecting an implementing agency the Central Government agencies viz. CPWD, NBBC etc., may also be considered by the State Government/District Authority. However, for certain works in certain Central Government Ministries/Organizations (like Railways) where the Implementing Agency has necessarily to be the concerned Central Government Ministry/Organization, the same shall be selected as the Implementing Agency.

4. This issues with the approval of Competent Authority.
