Sub: Full operationalization of newly developed integrated MPLADS portal -reg.

Sir,

As informed earlier through letters of even number dated 03.02.2014, 23.05.2014 and as discussed in the 18th All India Bi-annual review meeting of Nodal Secretaries held on 23.02.2015, it was emphasized that from 01.04.2015 newly developed integrated MPLADS portal will be fully operationalized.

2. It is observed that so far many Nodal District Authorities have not yet started uploading the data on '164.100.129.134/mplads', live server. Due to this the correct position is not being reflected in various reports, viz., Expenditure Details, Priority Sector Reports, etc. These Statements are in the public domain. Non reporting of correct status by the Nodal District Authorities may create an impression that MPLAD scheme is not being effectively implemented by the District Authorities. It may also give scope to media/civil societies to make unwarranted avoidable imputations on Hon'ble MPs in utilization of MPLADS funds. The role of the Ministry/ State Governments in the implementation, monitoring and supervision of MPLAD Scheme may also be questioned. **It is, therefore, requested to ensure continuous and regular updation of data on '164.100.129.134/mplads', live server.**

3. Recently, it has come to the notice of this Ministry that non reporting is also due to non-availability of a link for filing details of MPLADS funds on 'mplads.nic.in'. In this regard it is once again reiterated that 16th Lok Sabha onwards and for sitting Rajya Sabha MPs all the reporting work should only be done on '164.100.129.134/mplads', live server. The test server,

'164.100.42.68/mplads', should be used for practicing purpose. User id and password of the Districts for live server and test server have already been conveyed to the District Authorities.

4. In compliance with the para 6.4 (viii) of 'Guidelines on MPLADS', **the Monthly Progress Report should also be submitted by the Nodal District Authorities to this Ministry positively by 10th of the succeeding month.**

On the basis of received MPRs the data is uploaded on the MPLADS website.

5. Guidelines for using this portal are available on MPLADS website. In case of any difficulty in using portal you may contact us on 'mplads@nic.in' and 'varman@nic.in'.

6. It is, therefore, **once again requested to use this newly developed integrated MPLADS portal for reporting of all the activities pertaining to MPLADS.**
