Sub: MPLADS works in the Sasaram constituency of Smt. Meira Kumar, MP and Hon'ble Speaker, Lok Sabha.

Sir,


I am directed to forward a copy of letter No.9/26/MPLADS/10-11 dated 3th November 2011 received from Lok Sabha Secretariat (MPLADS Committee Branch) on the subject mentioned above.

2. In this connection, the Committee on MPLADS (Lok Sabha) has informed that the latest data in respect of Sasaram Parliamentary constituency of the Hon'ble Speaker, Lok Sabha have not been uploaded on website of MPLADS. Further, there is a discrepancy in the recommended works and the amount mentioned for the works by the Hon'ble Speaker, Lok Sabha. It is observed that the District Authority has not sanctioned most of the recommended works by the Hon'ble Speaker, Lok Sabha and the commencement of recommended works has not been started even after a lapse of more than two years.

3. You are, therefore, requested to direct the concerned authorities to take necessary action to upload the latest status of the recommended works and their commencement on the website of MPLADS. The concerned authorities may also be directed to explain the reasons for discrepancy in the amount recommended, delay in sanction of works and non-commencement of works on time.

4. This may be treated as **Most Urgent** since the information is to be furnished to the Lok Sabha Secretariat for kind perusal of the Hon'ble Speaker, Lok Sabha.

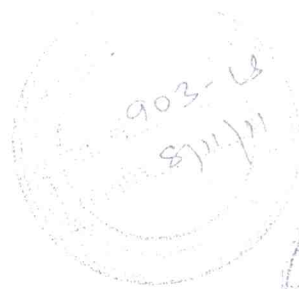

Subject: MPLAD works in the Sasaram constituency of Smt. Meira Kumar, MP and Honourable Speaker, Lok Sabha.

Sir,

From the data uploaded on the website of the Ministry of Statistics and Programme Implementation in respect of Sasaram constituency of Smt. Meira Kumar, MP, Hon. Speaker, Lok Sabha, the following has been observed :-

- (i) the amount recommended by Smt. Meira Kumar is Rs. 4.88 crore;
- (ii) The Report on 'Works not yet started' in Sasaram constituency for the 15th Lok Sabha indicates that 200 works recommended by Smt. Meira Kumar remain to be started; and
- (iii) The Report on 'Works not sanctioned' indicates that out of the 93 works recommended by Smt. Meira Kumar, 88 works recommended till end June 2011, are yet to be sanctioned.

2. In this connection it is stated that:
- (i) As per the information provided by the Office of Smt. Meira Kumar, works amounting to over Rs. 7 crore have been recommended by her for works in her constituency whereas the amount shown on the website is Rs. 4.88 crore;
 - (ii) As per the information given on the website, out of the 200 works recommended, 5 works were recommended in the year 2007, 62 in 2008 and 39 in 2009. Despite sanction of the works by the District Authorities, the works are yet to commence;
 - (iii) Out of the 93 works recommended by Smt. Meira Kumar till end June 2011, 88 works are yet to be sanctioned although under the MPLAD Scheme guidelines, the works are to be sanctioned within 75 days of its receipt.
3. It is, therefore, requested that the concerned authorities may be asked immediately to explain the following:
- (i) Discrepancy in the amount recommended;
 - (ii) Reasons for delay in sanction of works and non-commencement of works even after a lapse of more than two years.
4. The above information may kindly be furnished to the Secretariat by 18 November, 2011 positively for placing before the Hon. Speaker, Lok Sabha for her kind perusal.
